Mayor Mahon also commented on an editorial in the newspaper recently regarding the Governor's Horse Racing Commission on racing and methods of funding of purses and that as representatives of the Borough, the Borough actively supports horseracing at Monmouth Park and that this facility was a taxpayer unlike other facilities in the State. Mayor Mahon also commented on items being discussed such as twilight racing and that the Borough has been asked to be flexible in some of the items that may be necessary to maintain Monmouth Park now and in the future.

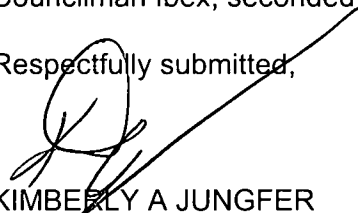
The Mayor then opened the meeting for anyone from the public who wished to be heard.
